Report of the Chief Executive

1. Purpose of the Report

1.1 To receive the third quarter's performance report for 2011/12 covering the period October 2011 to December 2011 as monitored against the Authority's Corporate Plan.

2. Background

- 2.1 Performance reports are produced on a quarterly basis and are an important part of the Authority's Performance Management Framework as they provide a mechanism for Members and officers to monitor and influence progress against the approved Corporate Plan.
- 2.2 This performance report is based on the Corporate Plan approved by Members at a meeting of the Authority held on 18th November 2011 and where appropriate, some targets have been updated.

3. Performance Report

- 3.1 Attached at Appendix 1 is the performance report for the third quarter of 2011/12.
- 3.2 The format approved by Members contains four sections as follows:

- **Section 4 Special Focus Report** a final section which provides in depth commentary and analysis on a specific topic each quarter.
- 3.3 Performance in the third quarter shows that environmental performance, particularly in relation to the Waste Management and Recycling Contract (WMRC) is encouraging. Whilst November figures for recycling and composting are slightly below target, this is expected due to the seasonal changes.
- 3.4 Performance in relation to educational visits to MRWA facilities has significantly increased this quarter with 1018 visits undertaken compared to a total of 355 visits during the previous two quarters combined. This improvement can be attributed in particular to the Authority's second Recycling Discovery Centre becoming fully operational at Gillmoss MRF.
- 3.5 Sickness absence levels have increased slightly, again due to seasonal effects, but the current forecast of 3.02% is on course to fall below the 4.21% target.
- 3.6 The special focus report for this quarter provides Members with an overview of how the Authority manages the aftercare of the closed landfill sites for which it has a statutory duty to manage.
- 3.7 Members' views are sought on any other specific areas of focus they would like to see included in future reports.
