### **Report of the Treasurer**

#### 1. <u>Purpose of the Report</u>

1.1 To present to Members the Annual Audit Letter and to report the outcome of the 2014/15 audit undertaken by the Authority's external auditor, Grant Thornton.

#### 2. Background

- 2.1 Grant Thornton is appointed by the Audit Commission as the Authority's external auditor and is required to review various aspects of the Authority's activities in line with the requirements of the Audit Commission's Code of Audit Practice (the Code).
- 2.2 Grant Thornton produced an Annual Governance Report which was presented to Members at a meeting of the Authority held on 25<sup>th</sup> September 2015.
- 2.3 The report considered the auditor's findings in relation to the Authority's Financial Statements and Use of Resources (Value for Money Conclusion) for 2014/15 and the auditor issued an unqualified opinion for each.

### 3. 2014/15 Annual Audit Letter

- 3.1 Upon completion of the annual audit, Grant Thornton is required to publish an Annual Audit Letter which summarises the outcome of their work and makes specific recommendations for the coming year.
- 3.2 The Chief Executive has now received the Annual Audit Letter for 2014/15 which is attached at Appendix 1.
- 3.3 The 2014/15 Annual Audit Letter reports the Authority's position in relation to the following key areas:
  - the Authority's accounts; and
  - whether the Authority has made proper arrangements for securing economy, efficiency and effectiveness in its use of resources.

- 3.4 As noted above, the auditor has issued an unqualified opinion on the Authority's Statement of Accounts for 2014/15 and is satisfied that the Authority has put in place proper arrangements for securing economy, efficiency and effectiveness in its use of resources.
- 3.5 Members are asked to note comments made by the Auditor regarding the accounts process and the improvement to the Authority's financial position following the audit..
- 3.6 The Auditors also completed their work on this Authority's submissions foir the government's Whole of Government Accounts exercise with no significant issues being raised. The Audit has therefore been completed.
- 3.7 There have been no significant issues for the Authority arising from the external auditors' work, and there are no additional fees to be charged..

## 4. Risk Implications

- 4.1 The work carried out by the auditor assists the Authority in ensuring that arrangements are in place for the conduct of its business and that it safeguards and properly accounts for public money.
- 4.2 Failure to act upon the suggestions made by the auditor may affect the ability of the Authority in ensuring that such arrangements remain in place.
