Introduction

This document provides a statement to Department for Environment, Food and Rural Affairs (DEFRA) on progress currently being made on the review of the Joint Municipal Waste Management Strategy for Merseyside (JMWMS), in compliance with the requirements of the Waste and Emissions Trading (WET) Act 2003 and to provide an updated position on JMWMS development as a result of the Merseyside Waste Partnership's Bid to DEFRA for PFI Credits for the Residuals Waste Management Procurement Programme, this JMWMS Review Position Statement sets out:

- A summary of the active steps currently being taken by the Merseyside Waste Partnership to work together on the implementation of the Joint Municipal Waste Management Strategy for Merseyside
- 2. A synopsis of progress made to support the submission of the Outline Business Case (OBC) to DEFRA for PIF Credits
- 3. A summary of further strategy development planned to support the JMWMS review process

Summary

The Joint Municipal Waste Management Strategy (JMWMS) for Merseyside sets out a vision of how waste management arrangements will be developed and implemented over the short, medium and long-term to meet the challenges of dealing with the waste that we produce in Merseyside. It includes both immediate actions and longer term processes for ensuring we divert waste from landfill, particularly the biodegradable proportion, for which we have been set challenging targets.

1. Active steps taken to work together

Merseyside Waste Disposal Authority (MWDA), together with its constituent District Councils, Knowsley, Liverpool, Sefton, St Helens and Wirral, has formed a Partnership - known as the Merseyside Waste Strategy Partnership, to transform the way in which waste is managed in the future. The JMWMS sets out the way forward for the Partnership's joint working on the implementation of new waste management arrangements. The strength of the Partnership lies in some key actions agreed during 2005:

- Memorandum of Understanding between and approval to develop a closer binding Inter Authority Agreement (IAA)
- Approval of a tonnage based Levy
- Approval of a programme of work and financial commitment to the development of a Waste Local Development Document (WLDD) – now a Development Plan Document (DPD)
- Development of Integrated Waste Management Facilities at Bidston, Wirral and Gilmoss Liverpool part funded by a £5 million Grant for DEFRA'S Waste Minimisation and Recycling Fund

- The continuation of the Clean Merseyside Centre (CMC) Market
 Development Programme and development of a North West Regional
 Market Development Programme (noting that was a one of the key
 aspects agreed but this NW Regional Development programme is now
 in place, April 2006).
- Continued support for the DEFRA New Technologies programme
- Partnership approval by the Merseyside Leaders of a Expression of Interest for a PFI Credits bid to DEFRA to support the Residual Waste Management Contracts Procurement Programme

2. Synopsis of progress made

As part of the supporting programme by the Merseyside Waste Partnership to procure its next contracts for waste management, a review of the current JMWMS for Merseyside is needed in order to update the Strategy. The JMWMS for Merseyside will be reviewed during Spring 2006 to take account of the above. The following summary highlights the steps taken as part of the process and highlights progress to date:

3. Further JMWMS development (Review Programme)
