MRWA expects over £100m saving for Mersey authorities

Merseyside Recycling and Waste Authority has completed the procurement of its 30-year Waste Resource and Recovery Contract - and could save Merseyside and Halton taxpayers over £100m in the process.

The winning bid from the SITA UK-led group will transform waste management on Merseyside for at least the next three decades. More than 92% of Merseyside and Halton's 430,000 tonnes of annual non-recycled waste will be diverted from landfill, whilst also generating the equivalent electricity to power thousands of homes.

The high efficiency Energy from Waste facility with Combined Heat and Power will be built at the Wilton International site in Teesside and see the creation of around 50 new permanent jobs. There will also be a new rail hub for the transportation of waste at the existing Potter Group Rail Freight Terminal at Kirkby in Knowsley, creating around 25 new permanent jobs.

The Financial Close of the contract is expected to bring more than £100m worth of savings to the Authority and its partner councils over current landfill costs. The plant is expected to take two years to build and will start handling waste in 2016, with the rail terminal development in Kirkby starting in 2014.

Councillor Graham Morgan, Chairperson of MRWA, said: "Signing this contract puts in place a sustainable waste management solution for the next 30 years. The solution we have selected for Merseyside and Halton is the best for the environment – saving natural resources, generating green electricity and providing value for money for Merseyside and Halton taxpayers."

Jean-Louis Chaussade, CEO of Suez Environment, said: "This new contract fits well with Suez Environment's policy to develop new waste recovery facilities and divert waste material from landfill."

Huyton Household Waste Recycling Centre (HWRC) in Knowsley is hitting the heights as the best performing Centre in Merseyside.

Since it was opened over a year ago the facility has continued to improve recycling levels and divert more waste away from landfill. During the summer it managed to recycle and divert a record 85% of the waste accepted at the site.

This level of recycling performance has never been seen before on Merseyside and Huyton HWRC's performance can now be compared to the best Centres in the UK.

MRWA Chairperson and Knowsley Councillor Graham Morgan said: "We're delighted with the increased levels of recycling at all of our Recycling Centres, but especially pleased with Huyton. We made an investment in this new site and we're now seeing levels of recycling that reflect that investment."

In a recent customer satisfaction survey of over 1000 people the Huyton HWRC scored almost perfectly on site usage, including 100% for signage, layout, direction and the range of accepted materials. The site also scored 100% for Overall Satisfaction by users and for appearance and cleanliness.

All of the HWRC's are managed on the Authority's behalf by Veolia Environmental Services. Alex Paterson, Director at Veolia Environmental Services Merseyside and Halton said: "We are incredibly pleased with the results and performance at Huyton. Credit and thanks must go to the public using the new site at Huyton and to the site staff who have worked so hard to achieve these fantastic numbers."

Plans for new Liverpool Recycling Centre

Plans have been unveiled for the development of a new Household Waste Recycling Centre (HWRC) in Liverpool.

MRWA, working in partnership with Liverpool City Council, has identified a site off Cheadle Avenue in Old Swan as a possible location for the new facility, and it could become only the second facility of its kind in Liverpool – along with Otterspool HWRC – helping to boost the city's recycling rate.

Cllr Graham Morgan, Chairperson of MRWA, said: "By providing this facility it will not only help increase the city's recycling rates but will also relieve the pressure on our

Otterspool HWRC which in turn will help increase its efficiency."

Carl Beer, MRWA Chief Executive, said: "We're currently consulting with the local community as we know that local residents and businesses may have questions about the development of the site and how it will operate.

"Liverpool City Council will also consult with the public as part of the statutory planning process before deciding on the planning permission which has been submitted. If successful, we're hopeful that construction of the new HWRC will start in summer 2014, opening later in the year."



Otterspool is the only other HWRC in Liverpool.

Community projects to transform waste



More than a dozen community projects have been selected to spearhead a £235,000 waste initiative across Merseyside and Halton.

A total of 16 groups will deliver activities designed to have a direct impact on the amount of waste sent to landfill. The Fund is designed to help communities

across the region deliver the best ideas that make the biggest possible impact on the volume of waste sent to landfill each year.

Commercial crackdown at Recycling Centres

A recent initiative between MRWA and Liverpool City Council has been helping to crack down on the misuse of local Recycling Centres by businesses and traders who attempt to dispose of their waste at the sites.

The initiative has involved environmental enforcement teams from Liverpool City Council holding regular sessions at Otterspool Household Waste Recycling Centre (HWRC) and, where necessary, conducting investigations against vehicles suspected of carrying trade waste. The initial pilot has proved a success.

MRWA Member and Liverpool Councillor Laura Robertson-Collins said: "Genuine customers of our Centre at Otterspool can be reassured that this activity is taking place to protect them. All of Merseyside's Household Waste Recycling Centres are provided for household waste only – they are funded by the taxpayer, for the taxpayer."

The campaign has since been rolled out to other HWRCs in Merseyside.

This isn't the first initiative by MRWA and their contractor Veolia Environmental Services to put a halt on businesses using the Recycling Centres.

In 2009 a commercial vehicle Permit Scheme was launched at all sites across Merseyside to stop traders tipping commercial waste at the Centres. And more recently a trade waste recycling scheme was introduced at both Bidston and Huyton Recycling Centres, which offers a 'pay by the load' recycling and disposal service for businesses and their commercial waste.

Liverpool City Councillor Steve Munby said: "We are cracking down on the rogue traders and businesses who are abusing these facilities when they should be paying to dispose of their

waste – they are effectively defrauding taxpayers. There are many legitimate ways for business to dispose of their waste, which is the route they should take."
