26. **Community Fund 2013/14 – Funding Approval**  
**WDA/31/13**

A report was submitted which informed Members of applications received for the Community Fund and presented a number of options to deliver the programme in 2013/14.

**Resolved** that:

1. Option 3 as detailed in the report be selected and the applications referred to in paragraph 5.4 be approved and the Community Fund be increased by a further £105,987 in the current financial year to deliver the programme;
2. Funding Stream 3 be cancelled as a similar programme of activity to schools has been approved in Funding Stream 1; and
3. delegated powers of the Authority be granted to the Chief Executive, in consultation with the Chairperson, to award funding to the next highest scoring application above the minimum threshold, should any approved applications be withdrawn, or to the next project listed that can be delivered within the financial year up the amount of funding available.

28. **Resource Recover Contract (RRC) Legal Progress**  
**WDA/32/13**

The Authority considered a report which provided Members with an update regarding a legal challenge to the Resource Recover Contract (RRC) preferred bidder appointment. The report summarised the legal

Members voted unanimously and:

4. further reports be provided regarding the legal challenge prior to the Authority considering entering into the RRC with SITA.
